I. Historical Sketch.

The American Baptist Theological Seminary, an institution of learning for the training of black ministers and religious workers, was established in 1924. The seminary is jointly owned and controlled by the National Baptist Convention, Inc. and the Southern Baptist Convention. It is located in Nashville, Tennessee.

In 1913, E. Y. Mullins offered a resolution at the Southern Baptist Convention, calling for the establishment of a Negro Theological Seminary. A nine member committee was appointed to study the issue. The committee recommended the establishment of a seminary, but that it operate under the control of the National Baptist Convention.

Because of conditions resulting from World War I and a division in the National Baptist Convention, the founding and opening of the seminary was delayed until 1924. The seminary was first located on land adjacent to Roger Williams University in Nashville, Tennessee. The seminary opened on Oct. 1, 1924, with an enrollment of 28 men and 2 women. The first faculty consisted of William T. Amiger, J.H. Garnett, and O. L. Hailey. Sutton E. Griggs was elected the first president.

As approved by the Southern Baptist Convention, the objective of the Commission is to "act as liaison between the National Baptist Convention of the U.S.A., Inc. and the Southern Baptist Convention in matters relating to the American Baptist Theological Seminary and through the Seminary to assist generally in developing a strong program of ministerial education for National Baptists." The members of the Commission also serve as trustees for the seminary. The Executive director-treasurer of the Education Commission of the Southern Baptist Convention was asked to serve as secretary-treasurer of the Commission of the American Baptist Seminary in 1962.

The funds allocated by the Southern Baptist Convention provide operating funds for the seminary and scholarships for students in church related vocations. During the school year, 1987-88, the student body included 165 students. The institution's extension program had an enrollment of almost 600 students. In the 1990's the Southern Baptist Convention relinquished any ownership and authority over the American Baptist Seminary and the Commission was dissolved by Convention action.

II. Scope and Content.

The records of the Southern Baptist Commission on the American Baptist Seminary span the year 1913-1974, and include 10 linear ft. of material. The records document the origin and development of the American Baptist Seminary in Nashville, Tennessee.

The records contain the minutes of the annual meetings of the Seminary's Board of Trustees from 1924 to 1968, minutes of the Executive and Business Committees

of the seminary from 1924 to 1974, the minutes of the Executive Committee of the Southern Baptist Convention, and the minutes of the annual meeting of the Southern Baptist Commission on the American Baptist Seminary, 1940 to 1965. The minutes of the various meetings list attendees, agendas, actions of the group, reports, committee appointments, and financial statements. Also included are the subject and correspondence files of the executive director of the Commission. Included in these files are reports, articles, financial records, building files, charters and other historical papers, farm operation files, correspondence with the seminary president and faculty, and scholarship information.

Significant subjects covered in the papers include: incorporation of the Seminary in 1924; agreement on the operation of the seminary in 1949; the record of significant contributions of educators, administrators, and officials of the Southern Baptist Convention and the National Baptist Convention, U.S.A.; and the role of area pastors to the operation and success of the American Baptist Theological Seminary.

Arrangement. The material has been divided into four series. The series are listed below, showing date spans and folder numbers. The minutes are all arranged in chronological order.
